  - Maneability: 70 x 60m - outdoor, white sand + geotextile
  - Speed: 70 x 60m - outdoor, white sand + geotextile
- Warm-up arena: 60 x 25m – indoor, white sand + geotextile

## 8. Horses/stables/stabling fee/electricity connection:

**Box/per day:** 500 CZK/day – approx. 20 €/day

First day of the event, the boxes will be bedded with straw. Additional straw and hay will be available in the stable (included in the stabling fee). The boxes must be mucked out before horse`s departure, payment amounting to 100 CZK/box will be collected and subsequently returned after the mucked out boxes are checked.

The owner/rider is responsible for cleaning the box and feeding of his/her horse.

The parking site for horse trailers will be available close to the stables.

In case of withdrawal before the deadline for payments (14th June 2019), the fees are returned in full minus the regulation fee 20 CZK. In case of withdrawal before 28th June 2019, 6 p.m., the amount of 50% of the fees is returned. In case of later withdrawal, no fees are returned.

## **9. Veterinary regulations**

Before the horse is unloaded from the trailer (at the registration), the valid veterinary certificate or horse ID documents according to the Czech State Veterinary Administration regulations for animal transport must be presented. This requirement applies to all horses participating in the event, hence even horses stabled in the event location or nearby.

All horses must have ID documents issued by their country of origin. Please be informed that meeting of any export or transport requirements of your country of origin is fully your responsibility! All participating horses must be vaccinated according to the Czech Veterinary Regulations.

## **10. Insurance**

The organizer is not liable for any rider/horse injuries during the Event, as well as other accidents, illnesses, property losses or damages. All horse owners and riders are liable for any personal damage or loss caused to them, event facility employees, event officials, spectators and horses – we recommend to arrange for adequate personal insurance to cover your participation in the event.

## **11. Other dispositions**

1. The organizer reserves the right to make any changes to the program for the purpose of resolving any problems or unforeseen circumstances.
2. All horses must wear bridle with assigned identification number when moving along the event location (between boxes, warm-up and competition arenas).
3. The dogs must be strictly kept on the leash. Please be aware that the dogs off the leash endanger health and lives of the competitors!
4. Free admission for visitors.
5. Refreshments available in the event location – restaurant, buffet.

## **FOR THE WELFARE OF THE HORSE**

Considering that “Working Equitation Česká republika” association aims to bring the aspects of its activities as close as possible to the principles and objectives recognized in the international WAVE environment, the key principle is meeting requirements for horse welfare.

International organization WAVE aims to meet the highest standards of equestrian competition and therefore pretends at all times to safeguard the welfare of the horse. We strongly recommend that at all times following principles are met:

- That in all stages of the competition (during the preparation and training of competition horses) welfare must take precedence over all other demands
- Owners, trainers and judges have to be sure that horses and competitors are fit, competent and in good health before they are allowed to compete
- The events officials have to pay careful attention to the facilities (envolving competition areas, ground surfaces, stabling), weather conditions, site safety and fitness of the horse for onward travel after the event.
